The first Lieutenant Colonel in the chain of command is responsible and accountable for completing DA Form 4833 with support documentation (copies of Article 15s, court-martial orders, reprimands, etc) for all USACIDC investigations. The unit and brigade commander or their equivalent will also receive a copy of the DA Form 4833 for all USACIDC investigations.

Company, troop, and battery level commanders are responsible and accountable for completing DA Form 4833 with supporting documentation in all cases investigated by MPI, civilian detectives employed by the Department of the Army, and the PMO. Accurate and complete DA 4833 disposition reports are required to meet installation, command, HQDA, DOD, and federal statutory reporting requirements. The data is used to identify crime trends, establish command programs in law enforcement and other activities, and to ensure that resources are made available to support commanders who must address issues of soldier and family member indiscipline.

In court-martial cases, a conviction of an offense at court-martial may be for a different, or lesser included offense. List the offense for which the individual was convicted at court-martial in the remarks section. Provost Marshals must enter the "MP Report Number" (Block-1) for all cases referred to commanders. "Sub-Installation" (Block-1) is used to enter report number from a civilian law enforcement agency police report. Other information on the civilian law enforcement agency (e.g. civilian law enforcement agency address) may be entered in the remarks section.

**INVESTIGATIVE SUMMARY:**

This is an Operation Enduring Freedom Investigation.

This report was generated to correct Exhibits 97, 296, 312, 318, 326, and to add 346-348.

**FINAL REPORT:**

(U) INV (b)(6) (b)(7)(C), Military Police Investigations, Kandahar Airfield (KAF), Afghanistan, provided a Statement of PFC (b)(6) (b)(7)(C) detailing how he was physically assaulted by SSG BRAM, SSG GIBBS, SGT (b)(6) (b)(7)(C), SPC (b)(6) (b)(7)(C), SPC (b)(6) (b)(7)(C) CPL (b)(6) (b)(7)(C) and CPL MORLOCK after telling his chain of command the Soldiers, along with SPC WINFIELD and SPC KNAPP, were smoking hashish. Furthermore, PFC (b)(6) (b)(7)(C) alleged the individuals were also involved with killing unarmed Afghan civilians.

(U) Investigation established probable cause to believe SSG BRAM, SPC (b)(6) (b)(7)(C) PFC HOLMES, SGT (b)(6) (b)(7)(C), SPC (b)(6) (b)(7)(C), SPC KNAPP, SPC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) CPL MORLOCK, CPL (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C), SPC (b)(6) (b)(7)(C) and SPC WINFIELD wrongfully used and possessed hashish while on

active duty at FOB Ramrod. Investigation established probable cause did not exist to believe SSG GIBBS wrongfully used or possessed hashish at any time. Further, investigation established probable cause to believe PFC HOLMES, SPC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) and SPC KNAPP distributed hashish they obtained from unknown local national Afghan's to other unit members.

(U) Investigation established probable cause to believe SSG GIBBS, SSG BRAM, SGT (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) CPL MORLOCK, and CPL (b)(6) (b)(7)(C) physically assaulted PFC (b)(6) (b)(7)(C) by kicking, punching, and spitting on him for telling leadership that unit members were smoking hashish.

(U) Further investigation established probable cause to believe SSG GIBBS and CPL MORLOCK presented severed fingers to PFC (b)(6) (b)(7)(C) and threatened PFC (b)(6) (b)(7)(C) that he was going to end up deceased like the individual whose fingers were severed. Further investigation established probable cause to believe that SSG BRAM, SSG GIBBS, and SGT (b)(6) (b)(7)(C) were cruel to PFC (b)(6) (b)(7)(C) who was a junior enlisted member of their unit.

(U) Investigation established probable cause existed to believe that Mr. AGHA did not murder an unknown person near FOB Ramrod.

(U) Investigation established probable cause to believe CPL MORLOCK and SPC HOLMES conspired to murder a random Afghan local national and subsequently murdered Mr. GULBA DIN when they threw a grenade supplied by SSG GIBBS over a wall to simulate Mr. GULBA din attacking them, then firing their automatic weapons killing an unarmed Mr. GULBA DIN.

(U) Investigation established probable cause to believe SSG GIBBS, CPL MORLOCK and SPC WINFIELD conspired to kill a random Afghan local national and subsequently murdered Mr. ADAT when SSG GIBBS placed him on his knees and threw a grenade at him. SSG GIBBS then had SPC WINFIELD and CPL MORLOCK shoot at Mr. ADAT. Furthermore, SSG GIBBS walked up to the body of Mr. ADAT, and fired two rounds into his head with his M4. After killing Mr., ADAT SSG GIBBS then placed another grenade near the body to make it seem as if Mr. ADAT was attacking them.

(U) Investigation established probable cause to believe SSG GIBBS, SPC WAGNON and CPL MORLOCK conspired together to kill Mr. AGHA and when subsequently CPL MORLOCK and SSG GIBBS shot Mr. AGHA while he was unarmed and then SSG GIBBS planted an AK-47 near Mr. AGHA's body to make it seem as if he was attacking them at the time of the incident.

(U) Investigation established probable cause to believe SSG GIBBS provided false reports concerning the murders of Mr. ADAT, Mr. GULBA DIN and Mr. AGHA when he reported they were legitimate combat related deaths.

(U) Investigation established probable cause to believe PFC (b)(6) (b)(7)(C) knowingly provided a false

Statement when he denied using hashish while at FOB Ramrod.

(U) Investigation established probable cause to believe SSG STEVENS knowingly provided a false Statement when he denied partaking in the incident involving shooting at some farmers in a field.

(U) Investigation established probable cause to believe SFC (b)(6) (b)(7)(C) wrongfully provided grenades to SSG GIBBS.

(U) Investigation established probable cause to believe SSG GIBBS, SGT (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) SSG STEVENS, and SPC WAGNON shot at a group of unarmed farmers while on a dismounted patrol with the intent of killing them.

(U) Investigation established probable cause to believe SSG STEVENS wrongfully disposed of a grenade when he recklessly threw it off the back of his military vehicle to make it appear as if his unit was attacked. SSG STEVENS further submitted false statements concerning the incident to obtain his combat medical badge.

(U) Investigation established probable cause to believe SPC (b)(6) (b)(7)(C) knowingly provided a false Statement to this office when he stated he did not witness SPC MORLOCK and PFC HOLMES shoot Mr. GULBA DIN.

(U) Investigation established probable cause to believe SPC (b)(6) (b)(7)(C) threatened and assaulted CPL (b)(6) (b)(7)(C) when he shoved him against a HESCO barrier and told him not to talk to the authorities.

(U) Investigation established probable cause to believe SSG BRAM threatened PFC (b)(6) (b)(7)(C) with physical harm for telling about personnel in the unit smoking hashish.

**INVESTIGATIVE SUMMARY:**

**1st Final Supplemental:**

This is an Operation Enduring Freedom investigation.

This Final Supplemental report is being submitted to document the interviews of interpreters who assisted members of the 5/2 Stryker Brigade Combat Team during patrols as requested by the Office of the Staff Judge Advocate, Joint Base Lewis-McChord, WA 98433.

Multiple interviews of local interpreters assigned to 5/2 Stryker Brigade Combat Team, FOB Ramrod, did not produce new leads not known to this investigation.

**Final Report:**

(U) INV (b)(6) (b)(7)(C) Military Police Investigations, Kandahar Airfield (KAF), Afghanistan, provided a Statement of PFC (b)(6) (b)(7)(C) detailing how he was physically assaulted by SSG BRAM, SSG GIBBS, SGT (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) CPL (b)(6) (b)(7)(C) and CPL MORLOCK after telling his chain of command the Soldiers, along with SPC WINFIELD and SPC KNAPP, were smoking hashish. Furthermore, PFC (b)(6) (b)(7)(C) alleged the individuals were also involved with killing unarmed Afghan civilians.

(U) Investigation established probable cause to believe SSG BRAM, SPC (b)(6) (b)(7)(C) PFC HOLMES, SGT (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC KNAPP, SPC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) CPL MORLOCK, CPL (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) and SPC WINFIELD wrongfully used and possessed hashish while on active duty at FOB Ramrod. Investigation established probable cause did not exist to believe SSG GIBBS wrongfully used or possessed hashish at any time. Further investigation established probable cause to believe PFC HOLMES, SPC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) and SPC KNAPP distributed hashish they obtained from unknown local national Afghan's to other unit members.

(U) Investigation established probable cause to believe SSG GIBBS, SSG BRAM, SGT (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) CPL MORLOCK, and CPL (b)(6) (b)(7)(C) physically assaulted PFC (b)(6) (b)(7)(C) by kicking, punching, and spitting on him for telling leadership that unit members were smoking hashish.

(U) Further investigation established probable cause to believe SSG GIBBS and CPL MORLOCK presented severed fingers to PFC (b)(6) (b)(7)(C) and threatened PFC (b)(6) (b)(7)(C) that he was going to end up deceased like the individual whose fingers were severed. Further investigation established probable cause to believe that SSG BRAM, SSG GIBBS, and SGT (b)(6) (b)(7)(C) were cruel to PFC (b)(6) (b)(7)(C) who was a junior enlisted member of their unit.

(U) Investigation established probable cause existed to believe that Mr. AGHA did not murder an unknown person near FOB Ramrod.

(U) Investigation established probable cause to believe CPL MORLOCK and SPC HOLMES conspired to murder a random Afghan local national and subsequently murdered Mr. GULBA DIN when they threw a grenade supplied by SSG GIBBS over a wall to simulate Mr. GULBA DIN attacking them, then firing their automatic weapons killing an unarmed Mr. GULBA DIN.

(U) Investigation established probable cause to believe SSG GIBBS, CPL MORLOCK and SPC WINFIELD conspired to kill a random Afghan local national and subsequently murdered Mr. ADAT when SSG GIBBS placed him on his knees and threw a grenade at him. SSG GIBBS then had SPC WINFIELD and CPL MORLOCK shoot at Mr. ADAT. Furthermore, SSG GIBBS walked up to the body of Mr. ADAT, and fired two rounds into his head with his M4. After killing Mr. ADAT SSG GIBBS then placed another grenade near the body to make it seem as if Mr. ADAT was attacking them.

(U) Investigation established probable cause to believe SSG GIBBS, SPC WAGNON and CPL MORLOCK conspired together to kill Mr. AGHA and when subsequently CPL MORLOCK and SSG GIBBS shot Mr. AGHA while he was unarmed and then SSG GIBBS planted an AK-47 near Mr. AGHA's body to make it seem as if he was attacking them at the time of the incident.

(U) Investigation established probable cause to believe SSG GIBBS provided false reports concerning the murders of Mr. ADAT, Mr. GULBA DIN and Mr. AGHA when he reported they were legitimate combat related deaths.

(U) Investigation established probable cause to believe PFC (b)(6) (b)(7)(C) knowingly provided a false Statement when he denied using hashish while at FOB Ramrod.

(U) Investigation established probable cause to believe SSG STEVENS knowingly provided a false Statement when he denied partaking in the incident involving shooting at some farmers in a field.

(U) Investigation established probable cause to believe SFC (b)(6) (b)(7)(C) knowingly provided grenades to SSG GIBBS.

(U) Investigation established probable cause to believe SSG GIBBS, SSG (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C), SSG STEVENS, and SPC WAGNON shot at a group of unarmed farmers while on a dismounted patrol with the intent of killing them.

(U) Investigation established probable cause to believe SSG STEVENS wrongfully disposed of a grenade when he recklessly threw it off the back of his military vehicle to make it appear as if his unit was attacked. SSG STEVENS further submitted false statements concerning the incident to obtain his combat medical badge.

(U) Investigation established probable cause to believe SPC (b)(6) (b)(7)(C) knowingly provided a false Statement to this office when he stated he did not witness SPC MORLOCK and PFC HOLMES shoot Mr. GULBA DIN.

(U) Investigation established probable cause to believe SPC (b)(6) (b)(7)(C) threatened and assaulted CPL (b)(6) (b)(7)(C) when he shoved him against a HESCO barrier and told him not to talk to the authorities.

Afghanistan, provided a Statement of PFC (b)(6) (b)(7)(C) detailing how he was physically assaulted by SSG BRAM, SSG GIBBS, SGT (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) CPL (b)(6) (b)(7)(C) and CPL MORLOCK after telling his chain of command the Soldiers, along with SPC WINFIELD and SPC KNAPP, were smoking hashish. Furthermore, PFC (b)(6) (b)(7)(C) alleged the individuals were also involved with killing unarmed Afghan civilians.

Investigation established probable cause to believe SSG BRAM, SPC (b)(6) (b)(7)(C), PFC HOLMES, SGT (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC KNAPP, SPC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) CPL MORLOCK, CPL (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) and SPC WINFIELD wrongfully used and possessed hashish while on active duty at FOB Ramrod. Investigation established probable cause did not exist to believe SSG GIBBS wrongfully used or possessed hashish at any time. Further, investigation established probable cause to believe PFC HOLMES, SPC (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) and SPC KNAPP distributed hashish they obtained from unknown local national Afghans to other unit members.

Investigation established probable cause to believe SSG GIBBS, SSG BRAM, SGT (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C), SPC (b)(6) (b)(7)(C) CPL MORLOCK, and CPL (b)(6) (b)(7)(C) physically assaulted PFC (b)(6) (b)(7)(C) by kicking, punching, and spitting on him for telling leadership that unit members were smoking hashish.

Further investigation established probable cause to believe SSG GIBBS and CPL MORLOCK presented severed fingers to PFC (b)(6) (b)(7)(C) and threatened PFC (b)(6) (b)(7)(C) that he was going to end up deceased like the individual whose fingers were severed. Further investigation established probable cause to believe that SSG BRAM, SSG GIBBS, and SGT (b)(6) (b)(7)(C) were cruel to PFC (b)(6) (b)(7)(C) who was a junior enlisted member of their unit.

Investigation established probable cause existed to believe that Mr. AGHA did not murder an unknown person near FOB Ramrod.

Investigation established probable cause to believe CPL MORLOCK and SPC HOLMES conspired to murder a random Afghan local national and subsequently murdered Mr. GULBA DIN when they threw a grenade supplied by SSG GIBBS over a wall to simulate Mr. GULBA DIN attacking them, then firing their automatic weapons killing an unarmed Mr. GULBA DIN.

Investigation established probable cause to believe SSG GIBBS, CPL MORLOCK, and SPC WINFIELD conspired to kill a random Afghan local national and subsequently murdered Mr. ADAT when SSG GIBBS placed him on his knees and threw a grenade at him. SSG GIBBS then had SPC WINFIELD and CPL MORLOCK shoot at Mr. ADAT. Furthermore, SSG GIBBS walked up to the body of Mr. ADAT and fired two rounds into his head with his M4. After killing Mr. ADAT, SSG GIBBS then placed another grenade near the body to make it seem as if Mr. ADAT was attacking them.

Investigation established probable cause to believe SSG GIBBS, SPC WAGNON, and CPL MORLOCK conspired together to kill Mr. AGHA. Subsequently CPL MORLOCK and SSG GIBBS shot Mr. AGHA while he was unarmed. SSG GIBBS then planted an AK-47 near Mr. AGHA's body to make it seem as if he was attacking them at the time of the incident.

Investigation established probable cause to believe SSG GIBBS provided false reports concerning the murders of Mr. ADAT, Mr. GULBA DIN, and Mr. AGHA when he reported they were legitimate combat related deaths.

Investigation established probable cause to believe PFC (b)(6) (b)(7)(C) knowingly provided a false statement when he denied using hashish while at FOB Ramrod.

Investigation established probable cause to believe SSG STEVENS knowingly provided a false statement when he denied partaking in the incident involving shooting at some farmers in a field.

Investigation established probable cause to believe SFC (b)(6) (b)(7)(C) knowingly provided grenades to SSG GIBBS.

Investigation established probable cause to believe SSG GIBBS, SGT (b)(6) (b)(7)(C) PFC (b)(6) (b)(7)(C) SSG STEVENS, and SPC WAGNON shot at a group of unarmed farmers while on a dismounted patrol with the intent of killing them.

Investigation established probable cause to believe SSG STEVENS wrongfully disposed of a grenade when he recklessly threw it off the back of his military vehicle to make it appear as if his unit was attacked. SSG STEVENS further submitted false statements concerning the incident to obtain his combat medical badge.

Investigation established probable cause to believe SPC (b)(6) (b)(7)(C) knowingly provided a false statement to this office when he stated he did not witness SPC MORLOCK and PFC HOLMES shoot Mr. GULBA DIN.

Investigation established probable cause to believe SPC (b)(6) (b)(7)(C) threatened and assaulted CPL (b)(6) (b)(7)(C) when he shoved him against a HESCO barrier and told him not to talk to the authorities.

Investigation established probable cause to believe SSG BRAM threatened PFC (b)(6) (b)(7)(C) with physical harm for telling about personnel in the unit smoking hashish.

Further investigation consisting of interviews of interpreters who assisted members of the 5/2 Stryker Brigade Combat Team during patrols, as requested by the Office of the Staff Judge Advocate, Joint Base Lewis-McChord, WA 98433, did not produce any new information.

**INVESTIGATIVE SUMMARY:**

This is an Operation Enduring Freedom investigation.

INV (b)(6) (b)(7)(C) Military Police Investigations, Kandahar Airfield (KAF), Afghanistan, provided a Statement of PFC (b)(6) (b)(7)(C) which detailed how he was physically assaulted by SSG BRAM, SSG GIBBS, SGT (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C), SPC (b)(6) (b)(7)(C), CPL (b)(6) (b)(7)(C) and CPL MORLOCK after he told his chain of command the Soldiers, along with SPC WINFIELD and SPC KNAPP, smoked Hashish. Furthermore, PFC (b)(6) (b)(7)(C) alleged the individuals were also involved with killing unarmed Afghan civilians.

Investigation established probable cause to believe SSG BRAM, SPC (b)(6) (b)(7)(C), PFC HOLMES, SGT (b)(6) (b)(7)(C), SPC (b)(6) (b)(7)(C), SPC KNAPP, SPC (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C), SPC (b)(6) (b)(7)(C), CPL MORLOCK, CPL (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C) and SPC WINFIELD wrongfully used and possessed hashish while on active duty at FOB Ramrod. Investigation established probable cause did not exist to believe SSG GIBBS wrongfully used or possessed hashish at any time. Further, investigation established probable cause to believe PFC HOLMES, SPC (b)(6) (b)(7)(C), PFC (b)(6) (b)(7)(C) and SPC KNAPP distributed hashish they obtained from unknown local national Afghans to other unit members.

Investigation established probable cause to believe SSG GIBBS, SSG BRAM, SGT (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) SPC (b)(6) (b)(7)(C) CPL MORLOCK, and CPL (b)(6) (b)(7)(C) physically assaulted PFC (b)(6) (b)(7)(C) by kicking, punching, and spitting on him for telling leadership that unit members were smoking hashish.

Further investigation established probable cause to believe SSG GIBBS and CPL MORLOCK presented severed fingers to PFC (b)(6) (b)(7)(C) and threatened PFC (b)(6) (b)(7)(C) that he was going to end up deceased like the individual whose fingers were severed. Further investigation established probable cause to believe that SSG BRAM, SSG GIBBS, and SGT (b)(6) (b)(7)(C) are cruel to PFC (b)(6) (b)(7)(C) who was a junior enlisted member of their unit.

Investigation established probable cause existed to believe that Mr. AGHA did not murder an unknown person near FOB Ramrod.

Investigation established probable cause to believe CPL MORLOCK and SPC HOLMES conspired to murder a random Afghan local national and subsequently murdered Mr. GULBA DIN when they threw a grenade supplied by SSG GIBBS over a wall to simulate Mr. GULBA DIN attacking them, then firing their automatic weapons killing an unarmed Mr. GULBA DIN.

Investigation established probable cause to believe SSG GIBBS, CPL MORLOCK, and SPC WINFIELD conspired to kill a random Afghan local national and subsequently murdered Mr. ADAT when SSG GIBBS placed him on his knees and threw a grenade at him. SSG GIBBS then had SPC WINFIELD and CPL MORLOCK shoot at Mr. ADAT. Furthermore, SSG GIBBS walked up to the body of Mr. ADAT and fired two rounds into his head with his M4. After killing Mr. ADAT, SSG GIBBS then placed another grenade near the body to make it seem as if Mr. ADAT was attacking them.

Investigation established probable cause to believe SSG GIBBS, SPC WAGNON, and CPL MORLOCK conspired together to kill Mr. AGHA. Subsequently CPL MORLOCK and SSG GIBBS shot Mr. AGHA while he was unarmed. SSG GIBBS then planted an AK-47 near Mr. AGHA's body to make it seem as if he was attacking them at the time of the incident.

Investigation established probable cause to believe SSG GIBBS provided false reports concerning the murders of Mr. ADAT, Mr. GULBA DIN, and Mr. AGHA when he reported they were legitimate combat related deaths.

Investigation established probable cause to believe PFC (b)(6) (b)(7)(C) knowingly provided a false statement when he denied using hashish while at FOB Ramrod.

Investigation established probable cause to believe SSG STEVENS knowingly provided a false statement when he denied partaking in the incident involving shooting at some farmers in a field.

Investigation established probable cause to believe SFC (b)(6) (b)(7)(C) wrongfully provided grenades to SSG GIBBS.

Investigation established probable cause to believe SSG GIBBS, SG (b)(6) (b)(7)(C) PFC MOORE, SSG STEVENS, and SPC WAGNON shot at a group of unarmed farmers while on a dismounted patrol with the intent of killing them.

Investigation established probable cause to believe SSG STEVENS wrongfully disposed of a grenade when he recklessly threw it off the back of his military vehicle to make it appear as if his unit was attacked. SSG STEVENS further submitted false statements concerning the incident to obtain his combat medical badge.

Investigation established probable cause to believe SPC (b)(6) (b)(7)(C) threatened and assaulted CPL (b)(6) (b)(7)(C) when he shoved him against a HESCO barrier and told him not to talk to the authorities.

Investigation established probable cause to believe SSG BRAM threatened PFC (b)(6) (b)(7)(C) with physical harm for telling about personnel in the unit smoking hashish.

Further investigation consisting of interviews of interpreters who assisted members of the 5/2 Stryker Brigade Combat Team during patrols, as requested by the Office of the Staff Judge Advocate, Joint Base Lewis-McChord, WA 98433, did not produce any new information.
